

**Course Title:** Microcomputer Applications

**Course Number:** CPT 170 (OFFICE 2010 Version)

**Lecture hours per week:** 3.0

**Catalog Course Description:** This course is an introduction to microcomputer application software including word processing, databases, spreadsheets, graphs, and their integration. Presentation graphics are also covered. Note: Microsoft Office 2010 is used; keyboarding skills are recommended.

**Purpose of the Course:**

1. To provide a working overview of microcomputer hardware and its uses.
2. To provide a working knowledge of microcomputer software application packages, their purposes, and uses.
3. To provide hands-on experience through assigned lab exercises and problems.

**Required text(s):**

1. The Pearson Custom Program for CIS - CPT 170 Go! With Microsoft Office, a customized text book with myitlab Office 2010 Access Code - ISBN: 9781269620475; standalone Access code ISBN: 9781269522816
